	residential properties under one acre. Northfield Township Road District right-of-way is rural cross
	section with ditches and small diameter storm sewer. Discharge is to adjacent municipalities, Cook
	County, or IDOT stormwater systems. Northfield Township Road District does not directly discharge to
	any regulatory waterways.
